Il prodotto non contiene pentaclorofenolo, amine, cromo 6 o altri prodotti chimici dannosi per la salute.

Category 5-C: **Natural leather – First Quality** – Our first quality natural bovine leather tanned and dyed in barrel, is a soft to the touch, thermic and transpiring natural material, resisting to the test of time. This material, just because natural, can have possible defects that confirm the authenticity of the natural real leather and so not complainable. The product do not contain pentachlorophenol, amines, chrome 6 or any other chemical products that are harmful to health.

Catégorie 5-C: **Cuir Naturel- Première Qualité** – Notre cuir bovin a été tanné au chrome et teinté en tonneau, il est doux au toucher, thermique, anti-transpirant et résistant au passage du temps. 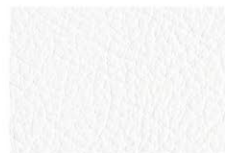
